Exelixis, Inc. Annual Meeting of Stockholders will be held on May 24, 2017 at 210 East Grand Avenue, South San Francisco, CA 94080, at 8:00 a.m. (local time). Upon arrival, please present your photo identification at the registration desk.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all nominees listed in Proposal 1, **FOR** Proposals 2, 3 and 4 and a vote for "ONE YEAR" on Proposal 5:

1. Election of the four Class III nominees for director named in the Proxy Statement to hold office until the 2020 Annual Meeting of Stockholders.
2. Ratification of the selection by the Audit Committee of the Board of Directors of Ernst & Young LLP as Exelixis' independent registered public accounting firm for the fiscal year ending December 29, 2017.
3. Approval of the Exelixis, Inc. 2017 Equity Incentive Plan.
4. Advisory approval of the compensation of the Exelixis' named executive officers, as disclosed in the Proxy Statement.
5. Advisory indication of the preferred frequency of stockholder advisory votes on the compensation of our named executive officers.

Other business as may properly come before the annual meeting or any postponement(s) or adjournment(s) thereof may be transacted at the meeting.
